

Terms & Conditions of the CRET Token Sale Agreement

PREAMBLE

The following terms and conditions of the CRET Tokens sale agreement (hereinafter - "Agreement") govern your (hereinafter - "You" or the "Purchaser") purchase of cryptographic tokens (hereinafter - "CRET Tokens") from Global Mark Ltd., a company incorporated in Seychelles, company number 204890 at Suite 1, Second Floor, Sound & Vision House, Francis Rachel Str., Victoria, Mahe, Seychelles (hereinafter - "We", "Us", "7Seconds" or the "Company"). The Purchaser and the Company each are "Party" and, together, the "Parties" to this Agreement agree as follows:

Acceptance & changes to this Agreement

1. Subject to the Terms&Conditions of the CRET Token Sale Agreement, Privacy Policy and KYC/AML Poolicy, the Company agrees to sell to you and you agree to purchase from Company a specific number of CRET Tokens at the price under section 39 of this Agreement.

2. By the fact of purchase of CRET Tokens from the Company and confirmation of acceptance of this Agreement and/or by clicking on the checkbox "I agree" at the website 7seconds.io as such actions are a symbol of Purchaser's signature, the Purchaser confirm that he/she/it have read this Agreement carefully and in its entirety and understand that HE/SHE/IT IS CONSENTING TO BE BOUND BY AND IS BECOMING A PARTY TO THIS AGREEMENT and any terms or agreement incorporated by reference AND AGREE THAT THIS AGREEMENT IS ENFORCEABLE LIKE ANY WRITTEN NEGOTIATED AGREEMENT SIGNED BY YOU. The Purchaser may withdraw from his/her/its obligations under this Agreement at any time under conditions of this Agreement.

3. Unless otherwise stated herein, this Agreement govern only Purchaser's acquisition of Tokens from 7Seconds during the Sale Period. Any use of CRET Tokens in connection with providing or receiving Services in the Platform shall be governed primarily by other applicable agreements and policies. The Company may use third party services to process

the Token Sale and any rules applicable by third party described in this Agreement to such processing of CRET Tokens should also be applicable in addition to this Agreement.

4. This Agreement is intended to fully reflect the terms and conditions of the original agreement between the parties. No provision of this Agreement shall be considered waived unless such waiver is accepted by the party that benefits from the enforcement of such provision by action of a click in a specific check box with the text "I agree" at the Website, which shall be published on the Website in such case. No waiver of any provision in this Agreement, however, will be deemed a waiver of a subsequent breach of such provision or a waiver of a similar provision. In addition, a waiver of any breach or a failure to enforce any term or condition of this Agreement will not in any way affect, limit, or waive a party's rights hereunder at any time to enforce strict compliance thereafter with every term and condition hereof.

5. The Purchaser acknowledges and accepts that this Agreement may be modified, changed, supplemented, updated at any time without prior written notice, at sole discretion of 7Seconds. Your continued use of the CRET Tokens after any amendments or alterations of this Agreement shall constitute Your consent hereto and acceptance hereof. At any case, the date of the most recent amendments and alterations will be indicated at the top of this Agreement. If the Purchaser does not agree to such revised terms of the Agreement he/she/it must stop using this CRET Tokens and may withdraw from his/her/its obligations under this Agreement at any time under conditions of this Agreement.

Interpretation

6. In this Agreement unless the opposite is clear from the context the following rules of interpretation apply:

1) Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular;

2) Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.

3) References to clauses and schedules are to the clauses and schedules of this Agreement and references to paragraphs are to paragraphs of the relevant schedule;

4) A reference to any party shall include that party's personal representatives, successors and permitted assigns.

5) All references to a person include firms, companies, government entities, trusts and partnerships or other or unincorporated body (whether or not having separate legal personality);

6) The term 'including' does not exclude anything not listed;

7) A reference to a statute or statutory provision is a reference to it as amended, extended or re-enacted from time to time;

8) A reference to a statute or statutory provision shall include all subordinate legislation made from time to time under that statute or statutory provision.

9) A reference to writing or written includes fax and e-mail.

10) Any obligation on a party not to do something includes an obligation not to allow that thing to be done.

11) Any words following this Agreement including, include, in particular, for example or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding or following that agreement.

12) Headings of sections are for convenience only and shall not be used to limit or construe such sections. All the sections in this Agreement shall survive any termination or expiration of this Agreement.

"CRET Token"	Digital cryptographic token, which is a software digital product (not being cryptocurrency), created and issued by the Company as a cryptographically secured representation of the right to exchange CRET Token for services on the Platform and which give the Purchaser access to certain features on the Platform.
"CRET Tokens Sale"	An offering, public sale and distribution of CRET Tokens to eligible Purchasers held during a limited period of time specified in section 39 of this Agreement.
"Smart Contract" or "Smart Contract System"	Digital computer protocol intended to facilitate, verify and enforce the negotiation and purchase of CRET Tokens by Purchaser.
"Website"	A group of interrelated websites owned and operated by 7Seconds, available in the Internet

via address 7seconds.io and special application based on blockchain technology.

7. The following definitions and rules of interpretation apply in this Agreement:

1. Certain statements in this Agreement and informational documents of the Company constitute “forward-looking information” under applicable laws. Except for statements of historical fact, information contained herein may constitute forward-looking statements. When used in this Agreement, the words “may,” “will,” “should,” “project,” “anticipate,” “believe,” “estimate”, “intend,” “expect,” “continue,” and similar expressions or the negatives thereof are generally intended to identify forward-looking statements. Forward looking statements are not guarantees of future performance, and undue reliance should not be placed on them. Such forward-looking statements necessarily involve known and unknown risks and uncertainties, which may cause actual performance on Company’s obligations, market projections and financial results in future periods to differ materially from any projections of future performance or result expressed or implied by such forward looking statements. Although forward-looking statements contained herein are based upon what management believes may be reasonable assumptions, forward-looking statements may prove to be inaccurate, as actual results and future events could differ materially from those anticipated in such statements. The Company expressly disclaims any obligation or undertaking to disseminate any updates or revisions to any forward-looking statement contained herein to reflect any change in its expectation with regard thereto or any change in events, conditions, or circumstances on which any such statement is based.

2. This Agreement is intended to fully reflect the terms and conditions of the original agreement between the parties. No provision of this Agreement shall be considered waived unless such waiver is accepted by the party that benefits from the enforcement of such provision by action of a click in a specific check box with the text “I agree” on the Website or Platform, which shall be published on the Website or Platform in such case. No waiver of any provision in this Agreement, however, will be deemed a waiver of a subsequent breach of such provision or a waiver of a similar provision. In addition, a waiver of any breach or a failure to enforce any term or condition of this Agreement will not in any way affect, limit, or waive a Party’s rights hereunder at any time to enforce strict compliance thereafter with every term and condition hereof.

Eligible purchasers

8. By purchasing CRET Tokens each Purchaser covenants, represents, and warrants that (under the Applicable Law and law of the country of Purchaser’s residence):

1) he/she/it is of an age of majority to enter into this Agreement (at least 18 years of age), meets all other eligibility criteria and residency requirements, and is fully able and legally competent to use the Website, enter into agreement with the 7Seconds and in doing so will not violate any other agreement to which he/she/it is a party;

2) he/she/it has necessary and relevant experience and knowledge to deal with cryptographic Tokens, cryptocurrencies and Blockchain-based systems, as well as full understanding of their framework, and is aware of all the merits, risks and any restrictions associated with cryptographic Tokens (their purchase and use), cryptocurrencies and Blockchain-based systems, as well as knows how to manage them, and is solely responsible for any evaluations based on such knowledge;

3) if he/she/it is a corporation or other legal entity, he/she/it has the right, power and authority to enter into this Agreement on behalf of the corporation or other legal entity and bind them to this Agreement;

4) Is not a foreign or domestic PEP.

5) he/she/it will not be using the Website for any illegal activity, including but not limited to money laundering and the financing of terrorism;

6) Purchaser created an Account on the Website and accepted 7Seconds Terms&Conditions, 7Seconds Privacy Policy and 7Seconds Cookies Policy.

9. Purchaser is only allowed to purchase CRET Tokens if and by buying CRET Tokens he/she/it covenant, represent, and warrant that you are neither a citizen, resident or tax resident of the United States of America (hereinafter referred to as the "U.S." or U.S. Person under definition of Rule 902 of the U.S. Securities Act of 1933), Canada, Seychelles and countries or territories or individuals under the sanctions of the United Nations or the European Union (the list is available at: https://eeas.europa.eu/sites/eeas/files/restrictive_measures-2017-08-04.pdf).

10. The U.S., Canada and Seychelles citizens and residents are not eligible and not allowed to participate in the CRET Tokens Sale due to various taxation and regulatory issues. Purchaser is only allowed to purchase CRET Tokens if he/she/it is neither a U.S. citizen or permanent resident of the mentioned states, nor Purchaser has a primary residence or domicile in the U.S. (including Puerto Rico, the U.S. Virgin Islands, and any other possessions of the U.S.), Canada and Seychelles. In order to buy CRET Tokens and by buying them Purchaser covenant, represent, and warrant that none of the owners of the company, of which Purchaser can be an authorized officer, are U.S. or Seychelles citizens or permanent residents. Should this change at any time, Purchaser shall immediately notify the Company. Purchaser also represent and warrant that he/she/it is not a citizen or resident of a geographic area in which access to or use of the cryptocurrency or cryptographic tokens is prohibited by applicable law, decree, regulation, treaty, or administrative act. The Company shall reserve the right to refuse to sell CRET Tokens to anyone who does not meet the citizenship and residence criteria set forth above. Purchasers cannot resell CRET Tokens to citizens and residents of countries and territories restricted in this Agreement.

Description of CRET Tokens

11. CRET Tokens are digital cryptographic tokens based on the Ethereum protocol technology and conform to the ERC-20 standard and serve as a software digital product (not being cryptocurrency), created and issued by the Company as a cryptographically secured representation of the right to exchange CRET Token for interaction and services on the Platform and which give the Purchaser access to certain features on the Platform.

12. There will be in total 645,000,000 (six hundred and forty five million) CRET Tokens available ("Total CRET Tokens Number") during the ICO.

13. CRET Tokens shall be distributed in the following manner:

- Sale (80%)
- Team (15%)
- Reserve for the loyalty program and risk compensation program (1%)
- Advisers (3%)
- Bounty (1%)

14. CRET Tokens carries no rights, express or implied, other than those, set out herein, subject to 7Seconds development of the project. In particular, CRET Tokens holders shall not have any influence in the development or governance of 7Seconds, and CRET Tokens do not represent or constitute any ownership right or stake, share or security or equivalent rights or any right to receive future revenue shares, or any other form of participation in or relating to 7Seconds.

15. Purchaser acknowledge and accept that CRET Tokens do not represent or constitute:

- a) any ownership right or stake, share, equity, security, commodity, bond, debt instrument or any other financial instrument or investment carrying equivalent rights;
- b) any right to receive future revenues, shares or any other form of participation or governance right from, in or relating to Company and Platform;
- c) any form of money or legal tender in any jurisdiction, nor do they constitute any representation of money (including electronic money).

16. Any potential future use of CRET Tokens in connection with the provision or receipt of services on 7Seconds Platform, shall be subject to and governed by such other applicable terms, conditions and policies relating to the use of each such service or Platform. Such terms and conditions regulating the use of the Platform shall be made available to the Platform users.

17. CRET Tokens are not consumer products and its holders accepts explicitly and agree to it that they are not covered by the consumer protection regulation of any jurisdiction.

Acknowledgement and assumption of risks related to CRET Tokens

18. Purchaser understands that CRET Tokens, blockchain technology, Ethereum and other associated and related technologies are new and untested and outside of 7Seconds' exclusive control and adverse changes in market forces or the technology, broadly construed, may prevent or compromise 7Seconds' performance under this Agreement.

19. Purchaser agrees that no other party (including, without limitation any) may be held liable for any loss arising out of, or in any way connected with Purchaser's participation in the CRET Tokens-sale, or receiving and holding Tokens or such risk.

20. Purchaser also acknowledges that prior to receiving CRET Tokens he has been warned of the following risks, associated with the Website, the 7Seconds Tokens, the Platform and other relevant technologies mentioned herein:

Legal risks regarding securities regulations

21. There is a risk that in some jurisdictions the CRET Tokens might be considered to be a security, or that it might be considered to be a security in the future. 7Seconds does not give warranties or guarantees that CRET Tokens are not a security in all jurisdictions. Each holder of CRET Tokens shall bear its own legal or financial consequences of CRET Tokens being considered a security in their respective jurisdiction. Every Purchaser is bound to check if acquisition and disposal of CRET Tokens is legal in his jurisdiction, and by accepting this Agreement, each Purchaser undertakes not to use CRET Tokens should their use not be legal in the relevant jurisdiction. If Purchaser establishes that the use of CRET Tokens under this Agreement is not legal in his jurisdiction, You should not use the CRET Tokens, not acquire them and should immediately stop using or possessing them if such case arises. Acquiring cryptographic Tokens for personal possession and exchanging them for other cryptographic Tokens will most likely continue to be scrutinized by various regulatory bodies around the world, which has so far given mixed reactions and regulatory impact. The legal ability of 7Seconds to provide CRET Tokens and the Platform in some jurisdictions may be eliminated by future regulation or legal actions. In the event, it turns out with a high degree certainty that CRET Tokens are not legal in certain jurisdiction, 7Seconds will either:

a) cease operations in that jurisdiction, or

b) adjust CRET Tokens and the Platform in a way to comply with the regulation should that be possible and viable.

Risks associated with Ethereum

22. CRET Tokens are based on Ethereum blockchain. As such, any malfunction, unintended function or unexpected functioning of the Ethereum protocol may cause the CRET Tokens to malfunction or function in an unexpected or unintended manner. More information about the Ethereum is available at <http://www.ethereum.org>.

Risk of unfavorable regulatory action in one or more jurisdictions

23. Blockchain technologies have been the subject of scrutiny by various regulatory bodies around the world. The functioning of the ERC-20 network and associated blockchain networks and CRET Tokens could be impacted by one or more regulatory inquiries or actions, including but not limited to restrictions on the use or possession of digital Tokens like CRET Tokens, which could impede or limit their existence, permissibility of their use and possession, and their value.

Risk of theft and hacking

24. Hackers or other groups or organizations may attempt to interfere with Your Third-party Wallet, the Website or the availability of CRET Tokens and Digital Assets in any number of ways, including without limitation denial of service attacks, Sybil attacks, spoofing, smurfing, malware attacks, or consensus-based attacks. You hereby agree that 7Seconds shall have no liability for any such loss the Purchaser incur.

Risk of security weaknesses in the Website and/or CRET Tokens source code or any associated software and/or infrastructure

25. There is a risk that the Website and CRET Tokens may unintentionally include weaknesses or bugs in the source code interfering with the use of or causing the loss of CRET Tokens.

Risk of weaknesses or exploitable breakthroughs in the field of cryptography

26. Advances in cryptography, or technical advances such as the development of quantum computers, could present risks to cryptocurrencies, Ethereum, ERC-20, CRET Tokens, the Platform, which could result in the theft or loss of CRET Tokens.

Risk of mining attacks

27. As with other decentralized cryptocurrencies, Ethereum blockchain, which is used for the CRET Tokens, is susceptible to mining attacks, including but not limited to double-spend attacks, majority mining power attacks, “selfish-mining” attacks, and race condition attacks. Any successful attacks present a risk to the CRET Tokens, expected proper execution and sequencing of CRET Tokens, and expected proper execution and sequencing of Ethereum contract computations in general. Despite the efforts of 7Seconds, the risk of known or novel mining attacks exists. Mining Attacks, as described above, may also target other blockchain networks, with which the CRET Tokens interact with and consequently the CRET Tokens may be impacted in that way to the extent, described above.

Risk of low or no liquidity

28. Even though there are currently online service available, which enable possibility of exchange of cryptographic tokens between themselves, and also, some of them enable exchange of cryptographic tokens for fiat money, there are no warranties and/or guarantees given that CRET Tokens will be listed or made available for exchange for other cryptographic tokens and/or fiat money, and no guarantees are given whatsoever with the capacity (volume) of such potential exchange. It shall be explicitly cautioned, that such exchange, if any, might be subject to poorly understood regulatory oversight, and 7Seconds does not give any warranties in regard to any exchange services providers. Purchasers might be exposed to fraud and failure. In any case, 7Seconds will not enable exchange of CRET Tokens for other cryptographic tokens or for fiat currency. Purchaser may not at any given time be able to acquire or dispose of its CRET Tokens due to lack of liquidity.

Risk of loss of value

29. Value of CRET Tokens may fluctuate and their Purchasers might suffer loss in value of such acquired tokens. There might be different reasons that would cause unfavorable fluctuations of the value of the CRET Tokens.

Risk of uninsured losses

30. CRET Tokens are unlike bank accounts or accounts at some other financial institutions and are entirely uninsured.

Risk of malfunction in the Ethereum network or any other blockchain

31. It is possible that the Ethereum network or any other network, to which the CRET Tokens are interacting with, malfunctions in an unfavorable way, including but not limited to one that result in the loss of CRET Tokens.

Internet transmission risks

32. Purchaser acknowledge that there are risks associated with using the CRET Tokens including, but not limited to, the failure of hardware, software, and Internet connections. Purchaser acknowledge that 7Seconds shall not be responsible for any communication failures, disruptions, errors, distortions or delays You may experience when using the Website and CRET Tokens, howsoever caused.

Unanticipated risks

33. Cryptocurrencies and blockchains are new and untested technology. In addition to the risks set forth here, there are risks that 7Seconds cannot foresee and it is unreasonable to believe that such risks could have been foreseeable. Risks may further materialize as unanticipated.

Insufficient interest in 7Seconds, the Platform and CRET Tokens

34. It is possible that 7Seconds, CRET Tokens or Platform will not be used by a large number of individuals, businesses and other organizations and that there will be limited public interest in the creation and development of its functionalities. Such a lack of interest could impact the development of the Platform and usage of CRET Tokens on it.

CRET Tokens and the Platform, as developed, may not meet the Purchaser's expectations

35. The Platform is currently under development and may undergo significant changes before release. The Purchaser's expectations regarding the form and functionality of the Platform and CRET Tokens may not be met upon release of new Website, deployment of the Platform, additional products and services for any number of reasons, including a change in the design and implementation plans and execution of the implementation of CRET Tokens.

Prohibited activities

36. You are prohibited from violating any law, statute, ordinance or regulation in our registered jurisdiction as well as your country or residency by using CRET Tokens.

37. You may not use your CRET Tokens to engage in the following categories of prohibited activity and you confirm that you will not use CRET Tokens to do any of the following: Engage in a transaction involving the proceeds of any unlawful activity;

- 1) Defraud or attempt to defraud 7Seconds or its affiliates;
- 2) Provide false, inaccurate or misleading information;
- 3) Infringe upon Company's or any third party's copyright, patent, trademark, or intellectual property rights;
- 4) Take any action that imposes an unreasonable or disproportionately large load on infrastructure of 7Seconds, or detrimentally interfere with, intercept, or expropriate any system, data, or information;
- 5) Transmit or upload any material to the Platform that contains viruses or malware or any other harmful or deleterious programs;
- 6) Otherwise attempt to gain unauthorized access to the Platform and Website, computer systems or networks connected to the Website, through password mining or any other means;

38. Company reserves the right at all times to monitor, review, retain and/or disclose any information as necessary to satisfy any applicable law, regulation, legal process or governmental request. 7Seconds reserves the right to cancel and/or suspend your Account and usage of 7Seconds Tokens immediately and without notice if Company determine, in its sole discretion, that your Account and usage of CRET Tokens is associated with prohibited use, and/or a prohibited business, and or illegal activity under Applicable law.

Timeframe of CRET Token SALE

Purchase of CRET Tokens may be made during a defined period of time (hereinafter "CRET Token Sale Period"). The Token Sale Period shall commence from the [REDACTED] to [REDACTED].

Price of CRET Tokens

39. Purchasers in the CRET Tokens Sale will be allocated their CRET Tokens in exchange for Cryptocurrency accepted in Platform under Applicable Exchange rate for the day of the purchase at the following rate:

Payment procedure

40. CRET Tokens distribution and payment will be offered only through the Website. No third-party website or a different provider except ones listed on the Website allowed and has not been in any way supported, engaged, authorized or endorsed by 7Seconds and have no relationship in any way with 7Seconds. The only official and authorized website and CRET Tokens distribution provider is the Website available in the Internet via 7seconds.io. The Purchaser must ensure that the URL of your web browser indicates that it is using a hypertext transport protocol secure connection (“https”) and that the domain name is correct.

42. All payments in cryptocurrency shall be made at Company’s Smart Contract Address: 0xb58b3E52A3550e0BDCfe00B1918a760Bb7C0F33c

Delivery of CRET Tokens

43. After the receipt of transaction by the Company, 7Seconds shall transfer an amount of CRET Tokens equal to the payment amount under the prices for one CRET Token in section 39 of this Agreement to the Purchaser’s cryptographic wallet specified in Purchaser’s account.

44. 7Seconds reserves the right for an emergency stop functionality to terminate the distribution process. Use of this functionality shall remain in discretion of 7Seconds and shall only be used in limited situations, such as, but not limited to:

- 1) serious security issue detected;
- 2) serious network performance issue, depriving all users of equal treatment;
- 3) any type of material attack on the CRET Tokens, the Platform, Website or Ethereum network.

Cancellation / Refusal of purchase request

45. Any and all purchases of CRET Tokens are final and non-refundable unless contrary is not provided in this Agreement or by Applicable law. By purchasing the CRET Tokens, the Purchaser acknowledges that neither the 7Seconds nor any other of its affiliates are required to provide a refund for any reason, and that the Purchaser will not receive money or other compensation for any CRET Tokens that is not used or remains unused for any reason.

Timing of reimbursement

Withdrawal

47. In order to cancel the purchase during the reimbursement period Purchaser shall contact the Company in the writing form via contact@7seconds.com with demand for the cancellation and withdrawal of funds with documentary proof of purchase of CRET Tokens during the token sale and identification documents required under Sections 75-82 of this Agreement.

Returning of Tokens

48. After the consideration of the request by the Company and confirmation of the Purchase and request for the refund, Purchaser shall provide a cryptographic wallet address to which he demand a transfer of reimbursed fund. In no event shall the reimbursement amount exceed a USD equivalent of cryptocurrency paid for CRET Tokens at the date and time of purchase under Applicable Exchange Rate.

Deductions for distributed Tokens

49. Any commissions, gas, mining fees and expenses for refund of payment amount are not reimbursed by the Company.

Intellectual Property

50. 7Seconds has valid, unrestricted and exclusive ownership of rights to use the patents, trademarks, trademark registrations, trade names, copyrights, know-how, technology and other intellectual property necessary to the conduct of selling of the CRET Tokens and its commercial activities generally. This Agreement in no way shall entitle any Purchaser for any intellectual property of the 7Seconds CRET, including the intellectual property rights for the Website and all text, graphics, Purchaser's account interface, visual interface, photographs, trademarks, logos, artwork, and computer code, design, structure, selection, coordination, expression and other content connected to the Website. You are granted a limited, nontransferable, revocable license to view and copy the information from the Website and Platform solely for personal use only.

52. All intellectual property rights comprised in the information, text, graphics, logos, images, audio clips, data compilations, scripts, software, technology, sound or any other materials or works found in the Website and Platform shall vest in and remain property of 7Seconds and its affiliates. You are permitted to download and print such materials from the Website for personal and noncommercial use provided that You do not breach this Agreement.

52. 7Seconds and its affiliates retain all intellectual property rights, mostly, but not limited, to copyright, over the source code forming CRET Tokens, smart contract of the CRET Token Sale, Website and Platform.

53. There are no implied licenses under the this Agreement and any rights not expressly granted to the Purchaser hereunder are reserved by the Company.

54. If for the purpose of any intellectual property right registration of the 7Seconds, any documentary submission or any other action is required from the Purchaser, he/she/it must provide the Company with the respective assistance.

Representations and warranties

55. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW AND EXCEPT AS OTHERWISE SPECIFIED IN A WRITING BY 7Seconds, CRET Tokens ARE SOLD ON AN “AS IS” AND “AS AVAILABLE” BASIS WITHOUT WARRANTIES OF ANY KIND, AND 7Seconds EXPRESSLY DISCLAIM ALL IMPLIED WARRANTIES AS TO THE TOKENS, INCLUDING, WITHOUT LIMITATION, IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT; 7Seconds DOES NOT REPRESENT OR WARRANT THAT THE TOKENS ARE RELIABLE, CURRENT OR ERROR-FREE, MEET YOUR REQUIREMENTS, OR THAT DEFECTS IN THE TOKENS WILL BE CORRECTED; AND 7Seconds CANNOT AND DOES NOT REPRESENT OR WARRANT THAT THE TOKENS OR THE DELIVERY MECHANISM FOR TOKENS ARE FREE OF VIRUSES OR OTHER HARMFUL COMPONENTS.

56. By purchasing the CRET Tokens the Purchaser represent and warrant that he has read and understand this Agreement and all Accompanying Documents in full and he fully agree with the information about the functionality of CRET Token, usage, storage, transmission mechanisms and other material characteristics of the CRET Tokens, blockchain technology, blockchain-based software systems and their risks, and appreciates the risks and implications of purchasing the CRET Tokens.

57. You understand that the CRET Tokens confer only the right to exchange CRET Token for services on the Platform. You are not purchasin CRET Tokens for any other uses or purposes, including, but not limited to, any investment, speculative or other financial purposes.

58. The Purchaser fully understands, realizes and agrees that the CRET Tokens are created on a blockchain and are designed to be used in the manner described in Accompanying Documents Purchaser agree to accept consequences of possible regulation of CRET Tokens in jurisdiction of the Company incorporation and agree to provide all documents requested from 7Seconds in case of such regulation in order to comply with all requirements demanded from governmental bodies of jurisdiction of Company incorporation.

59. 7Seconds does not warrant or represent that any information on the Website is accurate or reliable or that the Website will be free of errors or viruses, that defects will be corrected, or that the service or the server that makes it available is free of viruses or other harmful components. 7Seconds shall not be liable for uninterrupted availability of the Platform for use of 7Seconds Tokens at all times, in all countries and/or all geographic locations, or at any given time.

60. Purchaser shall not forge, or otherwise manipulate any personal or non-personal data requested by the 7Seconds in the process of the Purchaser's registration (will not use the VPN or other means of distorting the data), or after its completion, will provide all necessary personal or non-personal data in the form and format requested by the 7Seconds in the event when such necessity arises in connection within the requirements of anti-money laundering and "Know Your Customer" (KYC) frameworks of the 7Seconds or in accordance with the Applicable law.

61. Purchaser's acquisition of the CRET Tokens complies with applicable laws and regulations in the Purchaser's jurisdiction;

62. Purchaser does not intend to hinder, delay or defraud 7Seconds or any other Purchasers of the 7Seconds Platform or engage in any illegal conduct and or unlawful activity in relation to money laundering, receiving the proceeds of drug trafficking or terrorist activities; receiving the proceeds of criminal activities, terrorist activities or trading with such countries as might from time to time be subject to any embargo imposed by the Security Council of the United Nations, the European Union or in any place of the world.

63. Some jurisdictions do not allow the exclusion of certain warranties or disclaimer of implied Agreement in contracts with consumers, so some or all of the exclusions of warranties and disclaimers in this section may not apply to the Purchaser.

Limitation of liability

64. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW:

1) IN NO EVENT WILL 7Seconds OR ANY OF THE COMPANY PARTIES BE LIABLE FOR ANY INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES OF ANY KIND (INCLUDING, BUT NOT LIMITED TO, WHERE RELATED TO LOSS OF REVENUE, INCOME OR PROFITS, LOSS OF USE OR DATA, OR DAMAGES FOR BUSINESS INTERRUPTION) ARISING OUT OF OR IN ANY WAY RELATED TO THE SALE OR USE OF THE TOKENS OR OTHERWISE RELATED TO THIS AGREEMENT, REGARDLESS OF THE FORM OF ACTION, WHETHER BASED IN CONTRACT, TORT (INCLUDING, BUT NOT LIMITED TO, SIMPLE NEGLIGENCE, WHETHER ACTIVE, PASSIVE OR IMPUTED), OR ANY OTHER LEGAL OR EQUITABLE THEORY (EVEN IF THE PURCHASER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND REGARDLESS OF WHETHER SUCH DAMAGES WERE FORESEEABLE); AND

68. The Purchaser bears the sole responsibility to determine if the purchase of CRET Tokens with Cryptocurrency or the potential appreciation or depreciation in the value of CRET Tokens over time has tax implications for the Purchaser in the Purchaser's home jurisdiction. By purchasing CRET Tokens and to the extent permitted by law, the Purchaser agrees not to hold any of the Company, its affiliates, shareholders, directors or advisors liable for any tax liability associated with or arising from the purchase of CRET Tokens.

69. Purchaser is solely responsible for withholding, collecting, reporting, paying, and/or remitting any and all taxes to the appropriate tax authorities in such jurisdiction(s) in which Purchaser may be liable to pay tax. Indemnification

70. To the extent allowable pursuant to Applicable Law, the Purchaser shall indemnify, defend, and hold the Company and/or its subsidiaries, affiliates, directors, officers, employees, agents, successors, and permitted assignees harmless from and against any and all claims, damages, losses, suits, actions, demands, proceedings, expenses, and/or liabilities (including but not limited to reasonable attorneys' fees incurred and/or those necessary to successfully establish the right to indemnification) filed/incurred by any third party against the Company arising out of a breach of any warranty, representation, or obligation hereunder.

Circumstances beyond the control of either party

71. The Purchaser shall not have any claim of any nature whatsoever against 7Seconds for any failure by Company to carry out any of its obligations under this Agreement as a result of causes beyond its control, including but not limited to power failure, Internet service provider failure, acts of God, epidemic, pandemic, civil unrest, fire, flood, droughts, storms, earthquakes, collapse of buildings, explosion or accident, acts of terrorism, acts of war, governmental action, any law or any action taken by a government or public authority, including without limitation imposing an export or import restriction, quota or prohibition, or any other event that is beyond the absolute and direct control of the 7Seconds.

Severability

72. If any term, provision, covenant or restriction of this Agreement is held by a court of competent jurisdiction to be invalid, illegal, void or unenforceable, the remainder of the Agreement, provisions, covenants and restrictions set forth herein shall remain in full force and effect and shall in no way be affected, impaired or invalidated, and the parties hereto

shall use their commercially reasonable efforts to find and employ an alternative means to achieve the same or substantially the same result as that contemplated by such term, provision, covenant or restriction. 73. All questions concerning the construction, validity, enforcement and interpretation of this Agreement shall be governed by and construed and enforced in accordance with the laws of Seychelles.

Dispute resolution

74. To resolve any dispute, controversy or claim between Parties arising out of or relating to this Agreement or the breach thereof, the Parties agree first to negotiate the issue in good faith for a period of not less than thirty (30) days following written notification of such controversy or claim to the other Party.

75. If the negotiations do not resolve the dispute, controversy or claim to the reasonable satisfaction of all Parties during such period, then the Parties irrevocably and unconditionally submit to the respective claim to the binding arbitration administered by the competent court of Seychelles in accordance with the rules of the arbitral tribunal, in English language, in writing on the basis of the documents submitted.

Termination

76. 7Seconds reserve the right, without notice and at its sole discretion, to terminate this Agreement or suspend the Purchaser's right to access the Website, including (but not limited to) in case of Purchaser's breach of this Agreement or if the 7Seconds believes You have committed fraud, negligence or other misconduct. The Purchaser may terminate this Agreement without notice by discontinuing use of the Website. All rights granted to the Purchaser under this Agreement will immediately be revoked upon our termination of this Agreement or 7Seconds suspension of the Your access to the Website. In the event of any circumstances beyond the control of the Parties, breach of this Agreement, or any other event that would make provision of services commercially unreasonable for 7Seconds, the Company may, in its own discretion and without liability to the Purchaser, with or without prior notice, suspend the Purchaser's access to all or a part of 7Seconds' Platform. 7Seconds may terminate the Purchaser's access to the Website in its sole discretion, immediately and without prior notice, and delete all related information and files related to such Purchaser without liability to You, including, for instance, in the event that the Purchaser breach any term of this Agreement. In the event of termination, 7Seconds will attempt to return any funds stored in Your smart contract number not otherwise owed to 7Seconds, unless 7Seconds believes the Purchaser has committed fraud, negligence or other misconduct.

OTHER CONDITIONS

77. Only English versions of any Company's communications are considered official. The English version of this Agreement shall prevail in case of differences in translation.

78. Any notice or other communication under this Agreement shall be in writing and shall be considered given and received when sent by email. The Purchaser's official email for communication shall be deemed the email specified by the Purchaser during the Application for Token Sale. The language of the communication shall be English.

79. Materials, such as 7Seconds White Paper, Development Road Map and others, published in the Website or elsewhere, are not binding and do not – unless explicitly referred to herein – form part of this Agreement, and are of descriptive nature only.

80. Except as otherwise provided in this Agreement, this Agreement and the rights and obligations of the parties hereunder will be binding upon and inure to the benefit of their respective successors, assigns, heirs, executors, administrators and legal representatives. Company may assign any of its rights and obligations under this Agreement. No other party to this Agreement may assign, whether voluntarily or by operation of law, any of its rights and obligations under this Agreement, except with the prior written consent of the Company.

81. The Purchaser will implement reasonable and appropriate measures designed to secure access to:

- 1) any device associated with the email address associated with the Platform;
- 2) private keys required to access any relevant ERC-20 and Ethereum address, and;
- 3) In case the Purchaser suspect a security breach in any of the above mentioned, he will inform 7Seconds immediately so 7Seconds can take all required and possible measures to secure the Website, the Platform, CRET Tokens and systems as whole.
